### **Marx Memorial Library**

The Marx Memorial Library & Workers' School was founded in 1933 in response to the rise of fascism in Europe. Its aim today remains the advance of education, knowledge and understanding of all aspects of Marxism and the history of socialism and working-class struggle. At the heart of the British labour movement for over 80 years, the Library is home to a unique collection of published and archival sources on related subjects, including the Spanish Civil War, trade unionism and peace and solidarity campaigns. The Library's education programme – online and on-site – covers subjects ranging from political and economic theory to socialist art.

The Marx Memorial Library holds the following contemporary documents on the Peterloo Massacre:

- An Impartial Narrative of the Late Melancholy Occurrences in Manchester. Printed and Published by Henry Fisher (1819)
- Report of the Metropolitan and Central Committee appointed for the Relief of the Manchester Sufferers with An Appendix containing the names of the Sufferers and the Nature and Extent of their Injuries. Also, an Account of the Distribution of the Funds and other Documents published by order of the Committee (1820)
- Sherwin's Weekly Political Register Vol V No. 16 21 August 1819 on 'Horrid Massacre at Manchester'.

We also hold three contemporary ceramics celebrating Henry Hunt and commemorating the Martyrs. These, too, form part of our James Klugman Collection and are searchable through our online catalogue here <https://marx.soutron.net/Portal/Default/en-GB/Search/SimpleSearch>

## **The Welsh Political Archive, National Library of Wales**

The Welsh Political Archive was established in 1983 to coordinate the collection of archives and documents relating to the political history of Wales.

- Harpton Court Estate Records (C816) Letter from Alfred Austin to Sir George Cornwall Lewis noting that Samuel Bamford wishes to have an accurate account of his trial after the Peterloo Massacre, July 16<sup>th</sup> 1848
- Bunsen and Waddington Letters (1/47) -file of letters from Frances Bunsen and Charles Bunsen to Mrs Waddington of Llanover Court. "thanks Mrs Waddington for account of [Manchester Massacre] or [Battle of Peterloo], October 13<sup>th</sup> 1819

### The Working Class Movement Library

The Working Class Movement Library is a national collection of the history of British and Irish radical and labour movements from the late 18th century up to the present day. It includes books, pamphlets, leaflets, banners, pottery, prints, photographs, personal papers, posters, videos, trade union records and much else that documents and illuminates the story of working class struggles for social justice, democracy and equality. The Library is open to everyone to visit by appointment between 10am and 5pm Tuesday to Friday, and the catalogue is available online at [www.wcml.org.uk/catalogue](http://www.wcml.org.uk/catalogue) - although not all material has yet been catalogued, this is often a useful first port of call.

Peterloo resources include:

Map that once belonged to William Hulton, the magistrate who ordered that the crowd be dispersed and Henry Hunt arrested. It shows the area surrounding St Peter's Fields and includes description of the yeomen and cavalry's movement on the day. The magistrate's signature and the name of the estate, Hulton Hall, are on the back. *Shelfmark: FRAMED/189.*

Three contemporary framed cartoons and two examples of the same commemorative headscarf (see [www.wcml.org.uk/catalogue](http://www.wcml.org.uk/catalogue)).

Scrapbook of newspaper cuttings relating to the Peterloo massacre, dating from 1956 to 1988 and useful for historiography. *Shelfmark: S52.*

Robert Walmsley - draft of his book *Peterloo: the case re-opened*. Extent: 6 boxes. *Shelfmark: AG Peterloo Walmsley.*

- Copy of the *Trial of Henry Hunt* that originally belonged to William Hulton, who gave evidence about the day's events in a trial which led to Hunt being sentenced to imprisonment for his part in them. Bound within the volume are a series of handwritten notes, taken by Hulton during the trial before he gave his several hours of testimony. This volume is to be digitised in 2019 thanks to funds from the Society for the Study of Labour History. *Shelfmark: D36*.
- Copy of *The Trial of Redford v. Birley* that also originally belonged to William Hulton; again he gave evidence at the trial. *Shelfmark: D55*.
- Report of the inquest into John Lees of Oldham, who died at Peterloo. *Shelfmark: D54*.
- Bamford, Samuel. *Passages in the life of a radical*. Manchester, [?1840], issued in parts - Vol 1 Nos 1-18 and Vol 2 Nos 1-16. *Shelfmark: D05*.
- *Papers relative to the internal state of the country*. London, 1819. *Shelfmark: X18*. Most of the reports here are of large bodies of reformers marching and drilling on the moors and other open spaces, prior to Peterloo.
- A bound volume of pamphlets, *Peterloo tracts*, including *Some observations as to the propriety of an enquiry into the late proceedings at Manchester: being an examination of the arguments, contained in the pamphlets of the Rev. Henry Phillpotts, M.A. Prebendary of Durham, and the Rev. John Davison, B.D. Rector of Washington*. Newcastle upon Tyne, 1819. *Shelfmark: D55*.
- Philips, Francis. *An exposure of the calumnies circulated by the enemies of the social order, and reiterated by their abettors against the magistrates and the yeomanry cavalry of Manchester and Salford*. London, 1819. *Shelfmark: D36*.
- And, last but not least, a first edition of Shelley's *Masque of Anarchy*, published by Edward Moxon in 1832.

### The John Rylands Library, Manchester

The John Rylands Library has a significant collection of Peterloo resources, the vast majority of which have been digitised and are available online. The key collections are the **Stamford Papers** and the **Wadsworth Papers**, the latter comprises material gathered by Rev. William Hay including handbills, placards and correspondence. A complete run of the newspaper *The Manchester Observer*, a key resource for anyone studying Peterloo, is also held at the Library and can be accessed online. Other key sources include the printed '**Manchester Sufferers**' book (Ref. R233016) and a manuscript book, '**The Peterloo Relief Fund Account Book**' (Ref. Eng MS 172), both of which carefully list the names, ages, gender, livelihoods and addresses of the victims and the amount of money they received in compensation.
